



Treon Gateway Software License Agreement

Treon Oy, November 2021

Single Use License

Please read this hardware and software license agreement ("license") carefully before using Treon Gateway.

By using Treon Gateway (all variants), you are agreeing to be bound by the terms of this license, unless you return the Treon Gateway as part of the return policy

If you do not agree to the terms of this license, do not use the Treon Gateway. If you do not agree to the terms of the license, you may return the Treon Gateway within the return period of fourteen (14) days to Treon or an authorized reseller/distributor where you obtained it for a refund.

1. General

- A. The software (including Boot ROM code and other embedded software), documentation, interfaces, content and any data that came with your Treon Gateway, whether on disk, in read only memory, on any other media or in any other form (collectively the "Treon Software") are licensed, not sold, to you by Treon OY ("Treon") for use only under the terms of this License. Treon retain ownership of the Treon Software itself and reserve all rights not expressly granted to you.
- B. Treon, at its discretion, may make available future updates to the Treon Software for your Treon Gateway. The Treon Software updates, if any, may not necessarily include all existing software features or new features that Treon releases for newer or other models of Treon Gateway. The terms of this License will govern any software upgrades provided by Treon that replace and/or supplement the original Treon Software on your Treon Gateway, unless such upgrade is accompanied by a separate license in which case the terms of that license will govern.

2. Permitted License Uses and Restrictions

- A. Subject to the terms and conditions of this License, and against full and timely payment of license fees if so agreed between you and Treon, you are granted a limited non-exclusive license to use the Treon Software on a single Treon-branded or Customer-branded Treon Gateway. You agree not to install, use or run the Treon Software on any non-Treon-provided device, or to enable others to do so. This License does not allow the Treon Software to exist on more than one device at a time, and you may not make the Treon Software available over a network where it could be used by multiple devices or multiple computers at the same time. This License grants you the rights to use Treon (proprietary) interfaces that are provided for third parties to extend Treon Gateway to connect to external interfaces including external cloud systems or computers, as well as enabling 3rd party sensors to connect to Treon Gateway. This License does not grant you any rights to use Treon intellectual property in the design, development, manufacture, licensing or distribution of third-party devices or third-party software applications and other intellectual property in the design, development, manufacture, licensing or distribution of third-party devices and accessories.

- B. You may not, and you agree not to or enable others to, copy (except as expressly permitted by this License), decompile, reverse engineer, disassemble, attempt to derive the source code of, decrypt, modify, or create derivative works of the Treon Software or any part thereof (except as and only to the extent any foregoing restriction is prohibited by applicable law or to the extent as may be permitted by licensing terms governing use of open-source components that may be included with the Treon Software).
- C. Title and intellectual property rights in and to any content displayed by or accessed through the Treon Software belongs to the respective content owner. Such content may be protected by copyright or other intellectual property laws and treaties and may be subject to terms of use of the third party providing such content.
- D. You agree to use the Treon Software in compliance with all applicable laws, including local laws of the country or region in which you reside.
- E. The Treon Software may periodically check with Treon for updates to the Treon Software. If an update is available, the update may automatically download and install onto your Treon Gateway. By using the Treon Software, you agree that Treon may download and install automatic updates onto your Treon Gateway. You can request to opt out of automatic updates by contacting Treon or your distributor.

3. Transfer

You may sell or otherwise dispose of Treon Gateway to your direct customers provided that you do not grant any kind of separate or derivative rights to the Treon Software. The transfer must include (a) your Treon Gateway and all of the Treon Software, including all its component parts, original media, printed materials and this License; (b) you do not retain any copies of the Treon Software, full or partial, including copies stored on a computer or other storage device; and (c) the party receiving the Treon Software reads and agrees to accept the terms and conditions of this License. All components of the Treon Software are provided as part of a bundle and may not be separated from the bundle and distributed as standalone applications. Treon Software provided with a Treon hardware product may not run on other models of Treon hardware.

4. Consent to Diagnostics and Updates

For diagnostic and product updates, you agree that Treon and its subsidiaries and agents may collect, maintain, process and use diagnostic, technical, usage and related information, including but not limited to unique system or hardware identifiers, information about your Treon Gateway, system and application software, and peripherals, that is gathered periodically to provide and improve Treon's products and services, facilitate the provision of software updates, product support and other services to you (if any) related to the Treon Software, and to verify compliance with the terms of this License. Treon may use this information for the purposes described above. To enable Treon's partners and third party developers to improve their software, hardware and services designed for use with Treon products, Treon may also provide any such partner or third party developer with a subset of diagnostic information that is relevant to that partner's or developer's software, hardware and/or services, as long as the diagnostic information is in a form that does not identify the customer.

5. Termination.

This License is effective until terminated. Your rights under this License will terminate automatically or otherwise cease to be effective without notice from Treon if you fail to comply with any term(s) of this License. Upon the termination of this License, you shall cease all use of the Treon Software. Sections 2B, 4, 5, 6, 7, 8, 9, and 10 of this License shall survive any such termination.

6. Warranties.

- B. You expressly acknowledge and agree that, to the extent permitted by applicable law, use of the Treon Gateway and software is at your sole risk and that the entire risk as to satisfactory quality, performance, accuracy and effort is with you.
- C. Treon does not warrant against interference with your enjoyment of the Treon software, that the functions contained in the Treon software will meet your requirements, that the operation of the Treon software will be uninterrupted or error-free, that defects in the Treon software will be corrected, or that the Treon software will be compatible or work with any third-party software or applications.

7. Limitation of Liability.

- A. to the extent not prohibited by applicable law, in no event shall Treon be liable for personal injury, or any incidental, special, indirect or consequential damages whatsoever, including, without limitation, damages for loss of profits, corruption or loss of data, failure to transmit or receive any data, business interruption or any other commercial damages or losses, arising out of or related to your use or inability to use the Treon Software or any third party software or applications in conjunction with the Treon Software, however caused, regardless of the theory of liability (contract, tort or otherwise) and even if Treon has been advised of the possibility of such damages. in no event shall Treon's total liability to you for all damages (other than as may be required by applicable law) exceed the amount of two hundred euros (300 Eur).

8. Controlling Law.

This License will be governed by and construed in accordance with the laws of Finland.

9. Complete Agreement.

This License constitutes the entire agreement between you and Treon relating to the Treon Software and supersedes all prior or contemporaneous understandings regarding such subject matter. No amendment to or modification of this License will be binding unless in writing and signed by Treon.

10. Third Party Acknowledgements.

Portions of the Treon Software may utilize or include third party software and other copyrighted material. Acknowledgements, licensing terms and disclaimers for such material are contained in the electronic documentation for the Treon Software, and your use of such material is governed by their respective terms.
